

AFTER SCHOOL SUPERVISION

Dear Middle School Parents:

We work hard to promote a community atmosphere at Augusta Prep. We are largely successful at this endeavor and enjoy the resulting comfort of our efforts. There is, however, one undesirable by product of this atmosphere which has grown considerably in the past few years. The number of unsupervised middle school students at varying hours of the day has increased. Recent conversations with middle school heads from around the country indicate that this is a national trend. While we love the fact that students enjoy being on campus, the liability incurred by the school is, in one middle school head's words, "legally foolish".

Augusta Prep will be providing an after school program in the middle school. The program will be available to students from 3:30 – 6:00 every day. The program will provide an atmosphere conducive to completing homework and direct age appropriate activities. The time distribution of these two aspects will be at the discretion of the director. A snack will also be provided. Families will be billed monthly. We encourage you to register your student. There is no cost to register.

Costs:

½ Day (3:30 – 4:30): Pre-registered \$10.00 per day
Drop-Off \$15.00

Entire Day:

Pre-Registered \$15.00 Per Day
Drop-Off \$20.00 Per Day

The middle school day ends at 3:00 p.m. Carpool is from 3:00 – 3:30. No middle school student will be allowed on campus unsupervised. Students who have not been picked up by 3:30 will be supervised in extended day and families will receive a statement billing for services.

Students who wish to attend after-school athletic contests of teams that they do not participate on must turn in a note from their parents by the conclusion of break the morning of the contest(s), 10:10 a.m. This note will indicate which contest(s) the student will be attending and when the student will be picked up. It will also acknowledge that there will be no formal supervision of their child after 3:30 and that they, the parent will assume responsibility for their child's behavior and safety. These permission notes are available in the middle school office.
